#### 5.0 AIRPORT UPDATE

# 5.1 Parafield Airport Limited (PAL) Report

The report was tabled and taken as read and the below was noted: Total Movements for the month are higher than prior year with an increase in circuit activity. Traffic for the December 2024 quarter reached 60,342 movements, an increase from the corresponding quarter in the previous year being 57,944. It was noted that during the year PAL was a port for the Lyell McEwin Hospital while their helicopter pad was under repair. It was also noted that changes to tower hours occurred during the year which caused some disruptions.

# **5.2 Property Development Report**

The report was tabled and taken as read.

## 5.3 Environment Report

The report was tabled and taken as read and the following was noted:

The Department of Infrastructure, Transport, Regional Development, Communications, and the Arts (DITRDCA) are well advanced in their PFAS Investigations in-line with their Sampling Analysis and Quality Plans released in 2024. The PFAS Project Control Group was held during the quarter, it was noted that ASA have released their PFAS Detailed Site Investigation which has been reviewed by the Airport and Airport Environment Officer and comments have been provided.

Ongoing compliance monitoring events were completed during the quarter, including stormwater monitoring and completion of an updated Groundwater Monitoring Strategy for Parafield. Additional groundwater wells have been installed at Parafield to fill data gaps identified in the previous strategy. Site assessment was undertaken for the SAATAS Hanger located on the southern apron for lease exit. This work was completed indicating no soil or groundwater pollution caused by the tenant over its 40+ year lease.

A Cultural Heritage Management Plan developed previously for the known registered cultural heritage site on the airport has now been approved by Kaurna Yerta Aboriginal Corporation. PAL will now progress with control and management measures for this site.

Parafield undertook letterbox drops for approximately 45 properties along the western boundary of the airport to advise of night-works being completed as part of the Commonwealth PFAS Investigations program. No responses were received in regards to this.

One inquiry was received in relation to low-lead avgas used in aircraft at Parafield Airport. A response was provided to the resident and Parafield will be conducting further assessment on the use of low-lead avgas.

It was noted that 8 wildlife strikes were reported in the quarter which included 2 Nankeen Kestrels which is an unusual species to record at PAL.

A Committee member asked a question about odour from a stormwater drain. This item will be followed up.

# 5.4 Technical Working Group (PATWG)

A number of technical issues were discussed including concerns with the control tower due to insufficient staffing which puts pressure on the flying schools. A detailed presentation was provided on the circuit and fly neighbourly analysis. It was noted that a number of submissions received in response to the Parafield Airport Management Plan 2024 consultation identified matters related to the operation of aircraft and several suggested amendments be made to the permitted circuit hours contained in the Fly Neighbourly Program. In response to this community feedback, PAL committed

to presenting these matters to the PATWG for consideration. The recommendations are below:

- PAL prepare communications to all flight schools reminding operators of permitted circuit hours identified in the Fly Neighbourly and within the Parafield ERSA entry (this can include known non-Parafield based operators that data shows operate to/from Parafield).
- Where possible, flight schools provide PAL with advanced notice of periods corresponding to increased night circuit activity.
- PAL increase communications (e.g. social media) approaching periods of increased night circuit activity and at the start of day light savings to advise community that they may notice increased movements.

# 5.5 Parafield Airport Master Plan (PAMP)

It was noted that Minister King approved the Parafield Airport Master Plan and this has now been published and is available on the website <a href="Parafield-Airport-Master-Plan Final Digital-Complete-copy.pdf">Parafield-Airport-Master-Plan Final Digital-Complete-copy.pdf</a> or hard copies are available on request. # 6.2 State Department of Infrastructure and Transport (DIT) Report

No representative attended but an update provided at the Adelaide Airport Consultative Committee is below. Consultation closed on 16 December 2024 for the State's Transport Strategy and the feedback is being reviewed.

In December 2024, the <u>River Torrens to Darlington (T2D) Project</u> update was released and a new webpage was launched.

# 6.3 AirServices Australia (ASA) Report

It was noted that movements were consistent with the usual drop on Christmas Day traffic. 10 individual complainants were received and 8 suburbs recorded a complainant. The main issues were training and general aviation traffic. More information can be found here Airports - Airservices.
