#### 5.0 AIRPORT UPDATE

## 5.1 Parafield Airport Limited (PAL) Report

The report was tabled and taken as read and the following was noted: Parafield Airport uses data provided by AVData to record aircraft movements at Parafield Airport. There was a delay in published numbers as the data is manually recorded.

Total Movements for the month are lower than prior year with decrease in both landing and circuit activity, averaging 20,000 movements a month.

A field exercise was undertaken to simulate an airport emergency in July 2025 in accordance with the Civil Aviation Safety Regulations. The scenario involved two simulated crash sites, designed to test the management of multiple incident locations, as well as the command structure and communication flow between the Forward Command Post(s) and the Incident Control Centre in accordance with the Airport Emergency Plan and established Standard Operating Procedures. There was great participation from all emergency response agencies and the University of South Australia Mawson Lakes (which was the scene of the second crash site).

Parafield Airport provided \$500 donation to community radio station PBA FM 89.7 for their inaugural radiothon – Sound Future for Adelaide's Northern Voice. The donation will help the station undertake various projects in 2025/26 including relocation of the transmission tower.

Aviation students from University of South Australia Mawson Lakes, visited Parafield Airport in May. Special thanks to Aerotech and FTA for hosting the group.

Parafield Airport's work to reduce its carbon footprint has been recognised with the achievement of Level 4 Certification of the international Airport Carbon Accreditation program. The Airport Carbon Accreditation program is the only institutionally endorsed programme that independently assesses airports' efforts to manage and reduce their CO2 emission. There are five levels of accreditation with level 4 being Transformation – recognising airports that are transforming their operations and those of its business partners to achieve absolute emissions reductions.

#### **5.2** Property Development Report

The report was tabled and taken as read and the following was noted: Parafield Airport has received formal notification that Parafield Airport has not been selected as the preferred location for a new 20ha, 80,000sqm consolidated facility.

Construction has commenced on the OTR on Main North Road and will be a 12-month build.

## 5.3 Environment Report

The report was tabled and taken as read and the following was noted: Air quality monitoring was undertaken at Parafield between February and May 2025, no issues of concern were noted with air monitoring undertaken at Parafield, and the monitor will be redeployed following the Adelaide monitoring currently being conducted.

The Department of Infrastructure, Transport, Regional Development, Communications, Sport and the Arts (DITRDCSA) are well advance in their PFAS Investigations at Parafield Airport, having now completed airside works and now working through landside investigations. Ongoing compliance monitoring events were completed during the quarter, including stormwater monitoring with no reported elevated concentrations above adopted criteria.

PAL undertook additional tree planting in June in conjunction with Trees for Life. Approximately 1,000 native species of shrubs and canopy trees (seedlings) along the southern landside boundary. This will be watered and maintained by Trees for Life for 2 years until established.

No community complaints were received directly to the airport for the quarter in relation to ground based community impacts.

There were 3 confirmed strikes reported during the quarter and no significant damage recorded.

# 5.4 Technical Working Group (PATWG)

The Group met prior to this meeting and discussed Public Safety Areas, tower illness which affected tower hours but it was noted that new staff are coming onboard, movement numbers and data delay in AVData.
