#### 5.0 AIRPORT UPDATE

## 5.1 Parafield Airport Limited (PAL) Report

The report was tabled and taken as read and the following was noted: The movement activity is consistent with the previous year, which is predominantly training activity.

## 5.2 Property Development Report

The report was tabled and taken as read.

#### 5.3 Environment Report

The report was tabled and taken as read and the following was noted: The Department of Infrastructure, Transport, Regional Development, Communications, and the Arts (DITRDCA) are well advanced in their PFAS Investigations at Parafield Airport, having now completed airside works and now working through landside investigations. Ongoing compliance monitoring events were completed during the quarter, including stormwater monitoring and completion of groundwater well installations for the updated Parafield Groundwater Monitoring Strategy. Preliminary air monitoring was also undertaken for lead in air during the quarter at several locations over one day of operations. This was in response to an enquiry from the community regarding the use of low-lead fuels. No concentrations were reported as a result of this monitoring.

A Cultural Heritage Management Plan developed previously for the known registered cultural heritage site on the airport has now been approved by Kaurna Yerta Aboriginal Corporation. PAL has also now undertaken installation of control measures for the site including the installation of fencing around the site.

During the previous quarter, one inquiry was received in relation to low-lead avgas used in aircraft at Parafield Airport. As a result, lead monitoring was undertaken at various locations across the airport and a report provided back, with all lead concentrations reported below detection.

There was two confirmed strikes reported during the quarter, both Galah.

## 5.4 Technical Working Group (PATWG)

A number of technical issues were discussed including air traffic movements and FTA provided a comprehensive update on student and Cathay Pacific numbers.

## 6.1 Department of Infrastructure (DITRDCA)

No representative was present at the meeting, a report was provided which covered an update on the Aviation White Paper, Sunsetting and Aviation Industry Ombuds Scheme. Following the recent Federal election, it was noted that the current Minister, Minister King has remained in office.

## 6.2 State Department of Infrastructure and Transport (DIT) Report

The South Australian Premier recently announced that major works have commenced on the Torrens to Darlington (T2D) project, marking the start of construction on South Australia's largest infrastructure project.
